

710.1 PLAYING BALL IN THE PARK

SECTION ONE: No person or persons, children, or adults, shall play at any variety of ball games, regardless of what name such game may be called, if it is played with a ball of any description, in the City Park of this City, after the adoption and publication of this ordinance. Any person or persons violating this ordinance shall be fined the sum of Five Dollars (\$5.00). All ordinances or parts of ordinances conflicting herewith are hereby repealed.

ORDINANCE AMENDING

ORDINANCE NO. 730.02

IT IS HEREBY ORDERED AND ORDAINED BY THE CITY COUNCIL OF THE CITY OF VANCEBURG THAT:

SECTION 1: Henceforth, the Vanceburg boat dock and recreation area shall be opened at 6:00 a. m. and shall be closed at 10:00 p. m. Except that during the time of May through October 31 of each year, the hours of the boat dock shall be from 6:00 a. m. to 12:00 p. m. prevailing time.

SECTION 2: Henceforth, it shall be unlawful for any person, firm or corporation to be upon the premises of said boat dock or recreation area during the hours which said area is closed.

SECTION 3: That the City shall erect and maintain a cable or gate at the entrance of said boat dock and recreation area, and shall see that boaters are allowed reasonable ingress and egress to the boat ramp during the hours which said area is closed.

SECTION 4: Any person, firm or corporation which violates this ordinance shall be fined not less than \$5.00 nor more than \$500.00.

SECTION 5: This ordinance shall become effective upon passage and publication according to law.

ORDINANCE NO. 730.03

AN ORDINANCE SETTING THE HOURS OF THE CITY PARK ON FRONT STREET
IT IS HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF
VANCEBURG, KENTUCKY, as follows:

Section 1: The hours of the City Park on Front Street shall be
as follows: Said park shall be open from 6:00
a. m. to 11:00 p. m. each day of the week, prevailing
time. It shall be unlawful for anyone to be
upon the premises of said park during the time said
park is closed.

Section 2: Any person, firm or corporation found in violation
of this ordinance shall be fined not more than
\$10.00.

Section 3: This Ordinance shall become effective upon passage and
publication according to law.
